

NOTICE

Tender notice bearing No. 4/ESTT/GZA/NIT/2017-18 dated 12-07-2017.

(Specifications & Conditions of Tender)

Sealed tenders from the bonafide agencies will be received by the undersigned between 17th July, 2017 to 2nd August, 2017 except thursday between 11.00 A.M. to 4.00 P.M. for catering the stall (scheduled below) for the period of 3 (three) years with effect from 01-10-2017 under the following terms & conditions.

NAME OF CATERING STALL

Stall in front of the Ram Brahma Sanyal Smriti Sadan, Zoological Garden, Alipore.

1. The tenderers should submit a list of articles of food , snacks, beverages etc. as the case may be which they intend to cater and their respective prices with quantum of food and drinks along with their tenders. There should be some cheaper varieties within the means of the common people.
2. The successful tenderer will have to allow 25% rebate on approved rate of food articles, tea etc. as are cooked/prepared by them in their stall to the garden staff.
3. The usual terms of opening and closing of the stall will be 6.00 a.m. to 7.00 p.m. The hours may vary according to provisions of the West Bengal Shop and Establishment Act, 1963.
4. The licensee shall not exhibit any advertisement except displaying his own name.
5. On acceptance of tender, the licensee will execute an agreement, the terms and conditions of which are approved by the Director.
6. The Director of the Zoological Garden, Alipore and /or the licensee may terminate the contract by issue of one month's notice.
7. Tender should be addressed to the Director of the Zoological Garden, Alipore, Kolkata.
8. (a)Tender should be submitted along with the following self certified copies of licenses and documents etc:
 - i) Municipal License for professions, trade and sales.
 - ii) Municipal Health License.
 - ii) Current Income Tax Return and G. S. T. Registration certificate.
 - iii) Professional Tax.
 - iv) Prevention & food adulteration license.
 - v) Police License (where applicable).

8(b). An amount of Rs. 5000/- (Rupees five thousand) only in cash as earnest money shall have to be deposited by the tenderers immediately before submitting of their tenders which will be forfeited if the successful tenderer is unwilling to operate the stall on acceptance of the offer by the Director.

9. The Director has fixed the reserved license fee of Rs.30,000/- (Rupees thirty thousand) only per month and the said Director is not bound to accept the highest license fee or any tender or whatsoever. No. conditional tender will be considered.

10. The license fee will not include any other charges for running the business of catering. The agency shall have to bear all such charges e.g. electricity, water and gas consumption etc.

11. The license fee, so accepted by the Director, will be payable at the office of the Zoological Garden, Alipore as per terms and conditions to be laid down in the agreement fixed by the Director.

12. The tenderer whose tender will be accepted must enter into an Agreement and shall have to furnish Security Deposit equivalent to 2 (two) months' license fees. The Security Money is liable to forfeiture if the contractor/agency **fails to deposit license fee within the last day of the respective month with additional charge of twenty percent of the monthly license fee.**

13. Tenderer must satisfy the Director about the hygienic conditions of their products and articles offered for sale as well as the reasonableness of the prices of each item of food and drinks offered for sale at the stall.

14 The license, so granted by the Director to the agency, cannot be assigned or sublet in whole or in part to anyone else.

15. Tenderers who are not known to the Zoological Garden Authorities shall prove their bonafides by producing reference from recognized organization/ institution/ respectable persons along with tenders.

16. Stall should be created and maintained to the satisfaction of the Director at the cost of the successful contractor/ agency. Any renovation or improvement thereof made by him shall be subject to approval of designs by the authorities of the garden.

17. Tenders offered by any defaulting contractor may be liable to rejection.

18. The words "Tender for catering of stall near Ram Brahma Sanyal Smiriti Sadan" should be super scribed on the sealed cover.
19. **Use of conventional ' Chula' with coal/ firewood will not be permitted.**
20. Extension of area or creation of additional space outside the stall will not be permitted.
21. Separate private Meter for consumption of electricity in the stall will have to be installed by the successful tenderer at their own cost, initially a temporary connection from the garden source may be provided upon prayer of the licensee for which charges assessed by the garden authority will be paid them.
22. Other conditions will be embodied in the agreement.
